VENDOR RULES

- Traditional booth sizes in the downtown area are 10'x12'(wide); electrical service is included if registration is received by September 1, 2024.
- Booth sizes for Independent Distributors are 10'x10' and do not include electrical service.
- **ANAMOSA CHAMBER MEMBERS RECEIVE 25% DISCOUNT (not applicable to the late fee).**
- Additional Booth Spaces can be purchased at 25% discount of the applicable 1st space fee.
- Vendors are responsible for collecting/paying/reporting sales tax. Pumpkinfest is required to report all vendors attending to the State. Iowa no longer issues temporary sales tax permits, you must have a sales tax permit prior to the event.

 - » Not for Profit Vendors: A Not-for-Profit Status DOES NOT exempt you from sales tax.
 - » Multi-Level/Network Sales: If your company or sponsor pays sales tax for you, please provide their Iowa tax ID.
- Proof of Insurance **MUST BE** submitted with your application.
- All fees are due with registration and are NON-REFUNDABLE. Registrations received without payment will not be accepted.
- ALL REGISTRATIONS RECEIVED AFTER SEPTEMBER 1, 2024 OWE AN ADDITIONAL \$10 LATE FEE. NO EXCEPTIONS!!!
- IF YOU DO NOT HAVE THE REQUIRED PERMITS, YOUR APPLICATION WILL **NOT BE ACCEPTED.**
